No One Just 'Snaps': Recognizing and Understanding Real Threats and Warning Behaviors

A constituent bursts into City Hall and starts shooting. Did you see this coming? Did you recognize the warning behaviors? Did you tell anyone about your concerns? An angry ex-employee bursts into

the lobby of his former workplace and yells at the frightened receptionist, "You tell the Mayor he's a dead man." Is this a real threat? A member of the public stares directly at a municipal staff member and with alarming serenity says, "If you shut off my utilities, I'll kill you." What should you do? One of your staff members consults you because she is concerned a citizen is stalking her. Who do you notify?

These incidents range from the extreme of an attack to ambiguous statements, each of which can bring intense fear to the workplace. Public officials and their staff frequently interact with a wide range of individuals, some of who may pose a serious threat. Increasing awareness and practical knowledge of potential threats and threatening situations will better prepare you and your employees to identify, respond, and assist in the de-escalation of a threat and/or the possible prevention of a future attack.

Recent studies have proven that public officials are at the greatest risk of an attack. This session will address this unique trend including the most recent and relevant targeted violence studies. During this session, you will:

- Delve into the physiological and psychological aspects of violence and violent behavior;
- Discuss motivation and means of threats:
- Learn to identify specific behaviors of both threatening and non-threatening individuals, including warning behaviors and the "pathway to targeted violence;"
- Gather information and techniques that will enable you to be a better observer and reporter when engaging individuals who may pose a future threat to you or your fellow public officials.

Maura Kane is a popular Clerk educator in California serving as an institute and regional level trainer and has also recently trained in Colorado. Maura has developed additional courses specifically addressing Clerk specific issues to great interest. She offers her services to agencies when requested by Clerks and continues to interact and provides professional support following sessions.

Her experience in municipal government also includes working directly with local agencies in South Carolina while she worked at SLED.

Maureen Kane has served as an IIMC Institute Director in California since 2002. She is an active Clerk trainer at both the CCAC Institute and regional level. Her municipal government experience includes serving as a member of the Riverside City Council and as Chief of Staff for two mayors. She has attended all but one of the IIMC Annual Conferences since 2002 and has been an active participant in Institute Director meetings.

Effective Listening: What Is It You Are Really Hearing?

Have you ever had a conversation with someone and afterwards wondered what in the world you just talked about? Do you find yourself multitasking to the point that nothing has your undivided attention? Too often in conversations with others, our minds are on so many other things, so much so that we end up listening more to ourselves than the person with whom we are in a conversation! The gift of our complete and focused attention and listening is one of the kindest and most generous gifts we can offer another human being (and ourselves). K.D. Singh tells us, "with attention, we feel heard, seen, understood (valued); the power of that experience cannot be underestimated. We feel reconnected to our common humanity in the moment of being present with each other."

This session will focus on listening on various levels. Institute Director, Pamela Miller, will teach you to take control of your thoughts rather than having them control you, and experience the significant positive impact doing so has on your communication. As the foundation of attention in listening, through dialogue and exercises you will:

- Gain insight into the "simple" act of listening and the profound personal change it creates including transforming your relationships at work and at home;
- Explore the necessary mindset for good listening;
- Deepen your awareness of the various levels of listening and learn when it is appropriate to employ each;
- Develop skills in communicating with empathy;
- Gain insight into the potential impacts of ineffective listening through a generational perspective; and
- Gain skills in recognizing your own dialogue and how to refocus your attention.

Pamela Miller served as the Executive and Institute Director for Continuing Education for Public Officials (CEPO) from 2012 until September 2014 when the program transitioned into the Master Municipal Clerk Academy program that it is today. She has been designing curricula for the Clerks in California for more than 10 years. Recently, Pamela formed her own consulting firm, Miller Management & Consulting Group (www. millermca.com), and is now partnering with the City Clerks Association of California (CCAC) to provide the MMCA. Pamela also currently serves as the Executive Director for the California Association of Local Agency Formation Commissions (CALAFCO). CALAFCO is a nonprofit educational association to support the work of Local Agency Formation Commissions (LAFCo) in California.

Prior to returning to her native state of California in 2012, Miller lived and worked in Benton Harbor, MI, for six years. As Vice President for The Consortium for Community Development, a non-profit organization consisting of 27 state and local agencies, her work focused primarily

on the transformation of the community through individual, organizational, and community capacity building.

The Radar O'Reilly Phenomenon

IIMC introduced Daniel Porter to conference delegates in Montreal in 2017, when he delivered a session based on the ethically complicated Walter White of the hit TV series 'Breaking Bad.' This session was such a hit that we knew we had to bring Mr. Porter back to see what else he had up his sleeve!

The Radar O'Reilly Phenomenon will introduce you to Corporal Walter Eugene "Radar" O'Reilly, a simple boy from lowa who dreamed of joining the army right after high school. He was endowed with apparent extra-sensory perception, appearing at his commander's side before being called and finishing his sentences. He also had super-human hearing, able to hear incoming helicopters before anyone else. It was these abilities that earned him the nickname "Radar." But was it these same super-human abilities that allowed him to fly "under the radar"?

According to Daniel Porter, the Radar O'Reilly Phenomenon occurs when a mid-level administrator, at the nexus of an entity's financial transactions and responsible for enforcing adherence to internal controls, takes advantage of their opportunity and commits fraud. During this session, you will analyze the character behavior of Radar O'Reilly, one of the most beloved characters of the TV show M*A*S*H who was trusted by his boss to run the administrative side of the US Army medical unit. This session will delve into the elements of fraud and force you to think like a fraudster.

Were there red flags all around Radar? Did he have the opportunity to steal? We'll find out.

Daniel Porter, CFE, has conducted civil and criminal investigations for over 20 years as a licensed private investigator, a loss prevention manager, and as an investigator with the State of Tennessee. Currently, he is an investigative auditor in the Special Investigations Unit in the Office of the Comptroller of the Treasury, of the State of Tennessee where he investigates fraud involving public funds.

He is a Cum Laude graduate from Middle Tennessee State University's Criminal Justice Program and a Certified Fraud Examiner. He has provided training at AGA, AASHTO, CFE, GFOA, IIA, and NASACT conferences as well as for governmental agencies and professional organizations in various states including the Tennessee Bureau of Investigation, the Kentucky League of Cities, the Indiana CPA Society, and the Florida Institute of CPAs. He is a guest lecturer at Middle Tennessee State University and the Vanderbilt University School of Law.



In 2009, Major Mary Jennings Hegar saved her team from Taliban capture after their Medevac helicopter was shot down. Awarded both the Purple Heart and the Distinguished Flying Cross with Valor Device, Major Hegar's bravery in battle carried through to her landmark lawsuit against the Department of Defense to eliminate the Ground Combat Exclusion Policy that kept women from taking combat positions. After being denied a position in the Air Force, Hegar sued the Secretary of Defense, asserting that the Combat Exclusion Policy—which prevented women from entering direct combat—was unconstitutional. In a historic decision, the policy was repealed in 2013. Because of her, no soldier will ever be excluded from combat.

Major Hegar was once praised on the gun range by her superior for "shooting like a girl"—an ironic compliment that inspired the title of Shoot Like a Girl, her new memoir. Before the book (and soon-to-be motion picture, with Angelina Jolie set to star), Hegar risked her life on a near-daily basis, completing three tours of Afghanistan as a pilot with the Air National Guard. In keynotes that arrest both the heart and mind, she discusses the importance of teamwork as well as individual advocacy, inspiring us to embody the change we seek.

IIMC is honored to have Major "MJ" Hegar on board to assist with conference mission of "ALL Hands On Deck," as well as to be able to utilize her story as the focus of an Athenian Dialogue. In this keynote, MJ will reveal how to be a catalyst for change on a large scale, be it in your career, at home, or on a national or global level. Her heroic actions in Afghanistan changed the perception of women in the military. And, her historic lawsuit was a significant step forward for equal rights for women. So, how did she do it? Before John Glenn orbited the Earth or Neil Armstrong walked on the moon, a group of dedicated female mathematicians known as "human computers" used pencils, slide rules, and adding machines to calculate the numbers that would launch rockets and astronauts into space.

Among these problem solvers were a group of exceptionally talented African American women, some of the brightest minds of their generation.

Originally relegated to teaching math in the

South's segregated public schools, they were called into service during the labor shortages of World War II, when America's aeronautics industry was in dire need of anyone who had the right stuff. Suddenly these overlooked math whizzes had shots at jobs worthy of their skills, and they answered Uncle Sam's call, moving to Hampton, Virginia, and the fascinating, high-energy world of the Langley Memorial Aeronautical Laboratory.

Even as Virginia's Jim Crow laws required them to be segregated from their white counterparts, the women of Langley's all-black West Computing group helped America achieve one of the things it desired most: a decisive victory over the Soviet Union in the Cold War and complete domination of the heavens.

Starting in World War II and moving through to the Cold War, the civil rights movement, and the space race, Hidden Figures follows the interwoven accounts of Dorothy Vaughan, Mary Jackson, Katherine Johnson, and Christine Darden, four African American women who participated in


This book is a fascinating firsthand account by a veteran mission controller of one of America's greatest achievements -- landing a man on the moon. In Failure is Not an Option, Gene Kranz reflects on the creation of America's manned space program and his role as a key player in it for three decades. As a flight director in NASA's Mission Control, Kranz witnessed firsthand the making of history. He participated in the space program from the early days of the Mercury program to the last Apollo mission, and beyond. He endured the disastrous first years when rockets blew up and the United States seemed to fall further behind the Soviet Union in the space race. He helped launch Alan Shepard and John Glenn, and then assumed the flight director's role in the Gemini program, which he guided to fruition. With his teammates, he accepted the challenge to carry out President John F. Kennedy's commitment to land a man on the Moon before the end of the 1960s.

In this book, Kranz recounts these thrilling historic events and offers new information about the famous flights. What appeared as nearly flawless missions to the Moon were, in fact, a series of hairraising near misses. When the space technology failed, as it sometimes did, the controllers' only recourse was to rely on their skills and those of their teammates. He reveals behind-the-scenes details to demonstrate the leadership, discipline, trust, and teamwork that made the space program a success.

On June 29, 2009, Air National Guard Major Mary Jennings "MJ" Hegar was shot down while on a Medevac mission on her third tour in Afghanistan. Despite being wounded, she fought the enemy and saved the lives of her crew and their patients. But soon she would face a new battle: to give women who serve on the front lines the credit they deserve.

After being commissioned into the U.S. Air Force, MJ Hegar was selected for pilot training by the Air National Guard, finished at the top of her class, then served three tours in Afghanistan flying combat search and rescue missions, culminating in a harrowing rescue attempt that would earn MJ the Purple Heart as well as the Distinguished Flying Cross with Valor Device.

But it was on American soil that Hegar would embark on her greatest challenge—to eliminate the military's Ground Combat Exclusion Policy, which kept female armed service members from officially serving in combat roles despite their longstanding record of doing so with honor.

In Shoot like A Girl, MJ takes the reader on a dramatic journey through her military career: an inspiring, humorous, and thrilling true story of a


